

# STATEMENT OF QUALIFICATIONS APEC ARCHITECT PROJECT

## *United States APEC Architect Monitoring Committee*

The United States is a participant in the Asia-Pacific Economic Cooperation (APEC) Architect Project, which helps facilitate reciprocal registration for experienced architects in the Asia-Pacific region. To be recognized as an APEC architect, applicants are required to complete a statement of qualifications within participating economies, as per this form. Recognized APEC architects can apply for fast-track registration in other economies with which their home economy has reciprocal APEC architect arrangements. While the United States does not have mutual recognition arrangements with every country or economy in the APEC Architect Project, the framework facilitates the mobility of architects throughout the Asia-Pacific region.

### **REQUIREMENTS FOR REGISTRATION AS A UNITED STATES APEC ARCHITECT**

To be a United States APEC architect, you must:

- Be a registered architect in at least one (1) U.S. jurisdiction
- Hold an active NCARB Certificate
- Have at least seven (7) years of professional experience as a registered/licensed architect in the categories of practice specified below

#### **APEC Architect Professional Experience Requirements**

You must have practiced professionally for at least seven (7) years after initial registration as an architect and gained experience in all the following categories of architectural practice:

- Preliminary studies and preparation of brief
- Design
- Contract documentation
- Administration

At least **three (3) years** of your post-licensure experience must have been undertaken as an architect:

- With sole professional responsibility for the design, documentation, and contract administration of buildings of moderate complexity; OR
- In collaboration with other architects, as an architect in charge of and professionally responsible for a significant aspect of the design, documentation, and/or contract administration of complex buildings

Professional practice undertaken in an economy other than the United States MAY be acceptable.

You are required to submit at least three professional references who can confirm the information provided. References may be professional associates, clients, or others in a position to verify the statements submitted. Business partners should not be listed as a reference.

**You must renew your APEC registration every three (3) years.**
